# Proposal 1

## Payment of League Fees

Proposer: LMC

### Explanation

The LMC proposes that league fees are payable when teams are entered into the league.

### Proposal

Modify rules 1.2d

1 MEMBERSHIP

1.2 Member clubs

1.2d All subscriptions, fees and fines are payable to the League Treasurer within one month of receipt of a request for payment from the Treasurer.

As follows :-

1.2d All subscriptions, fees and fines are payable to the League Treasurer ~~within one month of receipt of a request for payment from the Treasurer.~~ upon application to enter teams in the League.

## Proposal 2

### Financial Year End

Proposer: LMC

### Explanation

With a current year end of 31 March it means that some expenditure (particularly that which is linked to the league congress) is passed into the next season.

A year end of 30 April should mean that all expenditure for the season takes place in one financial year.

Modify rules 2.5b

#### 2 MANAGEMENT

##### 2.5 The Treasurer

2.5b The Treasurer shall complete an Annual Account and Balance Sheet up to and including 31 March each year. These shall be certified by the Treasurer and the General Secretary and duly audited.

# **Proposal 3**

## **ECF Ratings**

Proposer: LMC

### **Explanation**

The ECF rating system allocates a rating to players after only one game. This can give new players wildly inaccurate ratings when they first start out.

The existing rule that new players use their first ECF rating for the rest of the season causes problems when that first rating can be based only on one game, specifically playing down eligibility and MKO team selection.

New players are differentiated in the ECF rating system by being given a P-rating. Players are given a P-rating until they have played 10 games. Once they have played 10 games their rating changes to a K-rating. Any player who plays 30 games in a season is given an A rating.

The proposal is that only A or K-ratings should be used during the season. Where a player does not have a rating or has a P-rating then their club should apply to the Grading Officer who will allocate them an appropriate rating.

Modify rules 5.3h and 7.3b

5.3h For parts f and g, where relevant, the ECF rating published on 1 September shall be used throughout the season. However, where a player has no September ECF rating but subsequently obtains one, such rating shall be used. For the avoidance of doubt, only the first such monthly rating shall be used.

## **Proposal 4**

### **Playing up/down**

Proposer: LMC

### **Explanation**

The LMC proposes that for strong players (rated between 1800 and 2099) there should be a limit to the number of times that those players should be permitted to play for a higher team.

However, the LMC recognises that for some clubs there can be great difficulty in providing transport for away matches. For some clubs there are players who are critical in providing transport and sometimes for more than one team. As such there are circumstances that require a strong player to be able to play more games than the proposed limit for a higher team. In such circumstances a club may apply to the LMC who can, if they see fit, waive the rule, and instead apply a different set of limitations.

### **Proposal**

Modify rule 5.3

#### **5 TEAM CHAMPIONSHIPS**

##### **5.3 Eligibility of players**

- 5.3f A player whose rating is above 2099 may only play for the team for which they are registered. However, where a club registers more than 6 players rated higher than 2099 then this restriction only applies to those 6 highest rated players. Any further players rated above 2099 may play for teams higher than the one for which they are registered a maximum number of 3 occasions in total.
- 5.3g Only a player whose rating is below 1800 is permitted to play for a team lower than that for which they are registered.
- 5.3h For parts f and g, where relevant, the ECF rating published on 1 September shall be used throughout the season. However, where a player has no September ECF rating but subsequently obtains one, such rating shall be used. For the avoidance of doubt, only the first such monthly rating shall be used.

## 5 TEAM CHAMPIONSHIPS

### 5.3 Eligibility of players

- 5.3f A player whose rating is above 2099 may only play for the team for which they are registered. However, where a club registers more than 6 players rated higher than 2099 then this restriction only applies to those 6 highest rated players. Any further players rated above 2099 may play for teams higher than the one for which they are registered a maximum number of 3 occasions in total.
- 5.3g Only a player whose rating is below 1800 is permitted to play for a team lower than that for which they are registered.
- 5.3h A player who is rated above 1799 but below 2100 may play for a team higher than that for which they are registered on a maximum of 4 occasions. If such a player plays a 5<sup>th</sup> game, then they will become registered for that higher team.
- 5.3i A club may apply to the LMC and request that a strong player who is logistically critical to that club be permitted to play for a higher team on more than 5 occasions. In such circumstances the LMC may waive rule 5.3h and apply a different set of limitations.
- 5.3j For parts f and g, where relevant, the ECF rating published on 1 September shall be used throughout the season. However, where a player has no September ECF rating but subsequently obtains one, such rating shall be used. For the avoidance of doubt, only the first such monthly rating shall be used.
